Tour Costs, Terms, and Conditions

Cost of Land Arrangements: US \$2,495 per person based on double occupancy\*

## **Tour Costs Include**

- 7 nights accommodation at Villa Pipistrelli with access to facilities at the estate of Montestigliano
- All breakfasts
- 5 lunches with wine
- 7 dinners with wine
- Ground transportation to all scheduled destinations
- Round-trip transfer from/to Florence Airport (April 5, 2014 and April 12, 2014). Point of arrival and departure of the tour is the Florence (FLR) airport. Participants are free to make alternate arrangements at their own expense.
- 2 cooking lessons
- Artisan Food and Wine Day (with guest experts)
- Art and Culture Day (with guest experts)
- Tours to Arezzo, Siena, and Tenuta di Spannocchia, as highlighted in the itinerary
- Entrance fees to museums and audio tour guide in Siena Cathedral
- All city taxes, hotel taxes, and tour guide fees

#### **Tour Does Not Include**

 Airfare, travel insurance, personal services or purchases, optional activities, excess baggage fees, gratuities to drivers and guides

## **Payment Schedule**

A **US \$500** nonrefundable deposit per person will reserve your place in the program. The balance of **US \$1,995** per person is due **December 12, 2013**. If payment is not received by this date (either by personal check, money order, electronic bank transfer, or PayPal option to pay by credit card), PergolaWest, Inc. shall consider the failed payment a cancellation and make the spot available for persons on the waiting list.

# **Cancellation Policy**

If you cancel within ninety (90) days (January 5, 2014 or later) of the Tour date, you will not receive a refund. We strongly recommend the purchase of trip cancellation insurance through your travel agent or online.

In the case of cancellation of the program by PergolaWest, Inc. for any reason (including not attaining the minimum of ten (10) persons needed to operate the Tour) prior to the Tour date, the refund of any monies held, including the deposit, shall constitute full settlement. In this occurrence, PergolaWest, Inc. and its representatives have no other

obligations to travelers on the cancelled Tour including any additional costs or fees related to the issuance and/or cancellation of airline tickets or other travel reservations not made by PergolaWest, Inc. We strongly recommend the purchase of travel insurance through your travel agent or online to protect yourself against any loss.

#### **Accommodations**

Villa Pipistrelli is comprised of two residence properties with a total of seven en suite rooms (double occupancy) with attached private baths. There are no single rooms. No smoking is permitted within the villas. If you wish to have a room to yourself, the land cost is \$4,990.

#### Meals

Breakfast is served at Villa Pipistrelli. Some lunches and dinners are served at Montestigliano (located approximately 1 mile from Villa Pipistrelli) and will feature traditional Tuscan cuisine. Meals will be abundant but, because this is an agriturismo and not a restaurant, cannot be customized to individual dietary needs. If you're not comfortable or unable to eat a wide range of freshly prepared whole foods, then this Tour probably isn't right for you.

You must be 21 years of age or older by April 5, 2014, in good physical and emotional condition, and able to manage hilly Tuscan terrain on foot. U.S. citizens and permanent residents are required to possess a valid passport to travel to Italy. If you are not a U.S. citizen or permanent resident, you are responsible for determining and fulfilling any visa requirements by contacting your country's embassy. If you are taking prescription medication, please make sure you have enough before leaving. All your personal information, address, emergency contact numbers, Tour Registration Form and Agreement, arrival information, etc., need to be in the possession of PergolaWest, Inc. prior to the start of the Tour. We will need your flight arrival and departure information into Florence Airport prior to the Tour.
